## General Terms and Conditions

These terms and conditions are legally binding and if the foregoing conditions or any other applicable conditions are not complied with, in addition to other remedies to Auctioneer and Seller by law, including without limitation, the right to hold the Bidder liable for the bid price, Auctioneer, at his option may (1) resell the property publicly or privately, with Bidder being liable for the payment of any deficiency plus all costs incurred, or (2) cancel the sale, retaining liquidated damages or payments made by Bidder. Auctioneer commission and all other incidental damages.

1. Bidder hereby agrees to assume the risk and to release and hold harmless Seller and Auctioneer and all of the persons or entities mentioned who might otherwise be liable to it or its successors or assign for damages.
2. Bidder shall provide current and complete registration information to Auctioneer. Providing false registration information to Auctioneer and Seller will result in Bidder being banned from all our auctions, and liable for any damages. Bidder must be 18 years of age or older to bid.
